- Rent is considered due in full and on time until the owners give a written approval.
- Tenants will be served a 3-day notice to pay rent or quit notice for any outstanding rent whether payment arrangements have been approved or not.
- A late fee will be assessed for any outstanding rent not received by the due date.
- Post dated checks are not allowed.
- Payment arrangements that are approved but not adhered to will void the approval from your owners and all rent will be due in full immediately.
- FAILURE TO COMPLETE THIS FORM IN IT'S ENTIREY, PROVIDING INACCURATE OR FALSE INFORMATION WILL RESULT IN AUTOMATIC DENIAL AND CONSIDERED GROUNDS FOR LEGAL ACTION IN ACCORDANCE WITH YOUR LEASE AGREEMENT!**
